The facility opened in 1989 and also offers an on-site manager and rental office with hours seven days a week. The property consists of over 6 acres of heavy industrial zoned land, with room to expand on a rear parcel of 2 acres. The facility has enjoyed consistently strong occupancy rates and offers outdoor parking spaces in addition to self storage units. Amenities include asphalt driveways, fenced perimeter, electronic keypad access gate, surveillance cameras and individual door alarms.
